

2020 AAU WINTER JUMP ROPE INVITATIONAL

Where: North Laurel Community Center, 9411 Whiskey Bottom Road, Laurel MD 20723

When: Saturday February 15, 2020 from 8:00 a.m. to 5:00 p.m.

Hosted by: Kangaroo Kids

Who Should Come? Anyone interested in competition Jump Rope for fun and jumpers wanting to get ready for the

spring competition season. This tournament is for both Novice and Experienced jumpers.

Events: Separate Novice and Experienced Division* in each Age-Group and Gender

Individual Single Rope Events:

Speed – 1 Minute - all ages, alternate feet for each rope rotation;

Power – 1 Minute – all ages, completed double unders are counted;

Freestyle to music - 60-75 seconds, all age groups;

1 Minute Timed Triple Unders – for ages 15+ only, combined age-division

*Novice = has never competed in an official jump rope competition

*Experienced = has competed in a previous official jump rope competition

Age-groups: 8 and under, 9-10, 11-12, 13-14, 15-16, 17-18, and 19-22

Separate Male and Female divisions

Age is determined by the competitor's age on June 15, 2020.

Note: Age groups may be combined if there are less than 3 entries in an event age group.

Awards: Gold medal to winner of each event, ribbons awarded for 2nd through 8th place

Participation ribbons for all participants.

Cost: \$40 registration fee, payable to Kangaroo Kids

Rules: 2020 AAU competition rules will apply. A copy of the 2020 AAU Jump Rope Rulebook

(Handbook) can be downloaded from the web at www.aausports.org; click on Jump Rope. All athletes and coaches must be current AAU members to participate in this tournament.

Freestyle music must be on an iPod, iPad or MP3 device.

Officials: Please note that for AAU Jump Rope Competition, one official must be provided for every 4

athletes competing from a team. All judges and officials must be current AAU members.

- 1. Team and Coach Info Worksheet: provide the required information for coach, coach of record, and support box people as indicated
- 2. Athlete and Event Entry Worksheet:
 - List name of each athlete competing and provide information requested in each column.
 - Please note: Novice Division is for first-time competitors only. If athlete has competed in a previous sanctioned jump rope competition, they are not eligible to compete again in Novice Division and will be in regular division.
- 3. Judge and Volunteer Nomination Worksheet: provide names of available judges and volunteers. Teams are required to provide a minimum of 1 trained judge for every 4 athletes competing, additional judges are always helpful! A judge that is only available either as just a speed judge or just a freestyle judge will count as 0.5 judge. Non-judging volunteers are also needed to help with this event.

Competition Location: North Laurel Community Center Gym, 9411 Whiskey Bottom Road, Laurel, MD 20723

Final Schedule of Events will be made available after registration deadline. Coach check-in tentatively scheduled for 8:30am, Judges/Officials Meeting at 8:50am, and Competition starting at 9:15am.

Notes:

- Participants may pre-order a lunch as part of registration, or they may bring a bag lunch or be prepared to go out to purchase lunch.
- Complimentary lunch for judges and officials will be provided.
- Jump Rope related merchandise will be available.
- Teams are required to provide 1 official, judge, or volunteer for every 4 competitors
- The deadline of January 17, 2020 must be observed; Late registrations must include \$10 late fee.
